## SUMMARY OF INTRODUCTION OF 2004 BUDGET:

Councilman Link read the following report from the Finance Committee:

The Borough Council is introducing the 2004 Municipal Budget tonight with total appropriations of \$13,764,179.15 and an Amount to be Raised for Municipal Purposes of \$10,095,268.72. The public hearing is scheduled for April 13, 2004 at 8 p.m. in the Municipal Building

The 2004 Municipal Tax Rate as introduced is \$1.159 per \$100 of Assessed Valuation which represents an increase of 12 points over the 2003 Local Tax Rate. A projected total Tax Rate is not possible at this time because of the uncertainty of the School and County requirements.

Some of the major budget issues to deal with are as follows:

- 1. Health insurance costs had a 10-15% increase which amounted to approximately \$122,500.
- 2. Despite continued aggressive sewer maintenance and repair programs sewer service charges increased by approximately \$44,500.
- 3. Item line for payment of Debt Service increased by \$254,000, due to the fact that this year=s budget reflects the first payment debt issued for new construction as well as the last payment of an old bond issue. Although the debt service line increased this year due to this overlap it was very important that the bonds were sold when they were last year to take advantage of the historically low interest rates. The end result will be that over the life of the new issue, there will be great savings sue to the timing of the sale and the favorable interest rate.

## SUMMARY OF INTRODUCTION OF 2004 BUDGET (cont=d):

- 4. Since the administration is to a great extent a service provider, a large percentage is for salaries and increases in salaries are estimated at approximately \$400,000. The 2004 budget as introduced is approximately 50% salaries.
- 5. Costs associated with liability and workmen=s compensation insurance increased by approximately \$36,000.
- 6. Interest rates have declined and the result is that we cannot anticipated any increase revenue from this source.

The net increase of the above items amounts to approximately \$857,000 which equates to 9.8 points, 82% of the entire increase represented by the introduced budget. An Extraordinary Aid Application will be submitted seeking funding to reduce taxes. Last year \$100,000 was received.

In 2003 the Borough generated approximately \$1,070,000 in surplus and realized a Tax Collection Rate of 98.75%.

She asked how many applications had been received for the night maintenance man and was told three or four.
