MISCELLANEOUS FROM PUBLIC:

Martin Van Dyke, 240 Ottawa Avenue, had several questions, one regarding a loud party on La Salle Avenue, if the ordinance could be amended to be an earlier time for loud noise. As this was not a recurring problem, he was asked for patience in this instance. He also asked who was responsible for cleaning under the overpass of Route 46 and was advised that it was just found out that the local municipalities are. Mayor Jones asked DPW Supt. Heck to sweep under the overpass. He also asked when the Madison Avenue entrance of the Municipal Building will be repaired and was advised that the insurance claim was now complete, and as supplies are received, repairs will be made.
