MINUTES

October 25, 2005

A Regular Meeting of the Mayor and Council of the Borough of Hasbrouck Heights was held on Tuesday, October 25, 2005 at 8:19 p.m. at Borough Hall, 320 Boulevard, Hasbrouck Heights, New Jersey.

Borough Clerk Rose Marie Sees stated that the meeting complied with the Sunshine Law, adequate notice of this meeting having been made to all members of the Council by personal service on January 4, 2005 and transmitted to The Observer, The Record and The Herald News on January 4, 2005.

SALUTE TO THE FLAG AND PLEDGE OF ALLEGIANCE: Mayor Jones led in the Salute to the Flag and Pledge of Allegiance.

INVOCATION: A prayer was given by Councilman Justin A. DiPisa.

PRESENTATION: Award of Check for Ceremonial Flag to Fire Department by Bergen Commercial Bank. Presenting the check was Phil Garry of Bergen Commercial Bank. Accepting the check was Councilman Meli, Chief Joseph Taylor, Richard Giarratana Captain and Al Cirelli, Lieutenant and Mayor Jones.

PROCLAMATION: Acknowledging Recreation Volunteer Al DeAngelo

REPORTS:

FINANCE AND SOCIAL SERVICES: Under Finance, Commissioner Link gave the Finance Report for the month of September. The current fund cash balance as of September 30, 2005 was \$1,815,994.75; on August 31 was \$3,895,167.81 which represents an decrease of \$2,079,173.06. The entire balance was invested and is earning 3.60%. Cash receipts for September totaled \$1,208,053.41 of which \$169,128.81 was for current taxes, \$9,613.99 was prior year taxes, \$881,396.80 was grants and state aid and \$147,913.81 was miscellaneous revenues. Cash disbursements for September totaled \$2,877,343.79 of which \$1,473,969.42 was local school taxes, \$528,468.49 was salaries, \$487,817.50 was debt service and \$387,088.38 was for other expenses. There was no Social Services report.

HEALTH AND PUBLIC FACILITIES: Under Health, Councilman DiPisa gave some health statistics for the month of September which included nine births, one death, 17 marriages, 434 certified transcripts, fees collected \$5,921, and five food licenses to food establishments. He reported the Health Fair Expo on September 30, was attended by 280 people, with 21 vendors. He thanked Dr. Aversa and Dr. Szanto for their expertise and Linda Brandle who organized the vendors. He thanked Charlotte Sodora and Wellington Care Center who donated the lunch, and thanked Lou Castellito and Marilyn deRussy. There were 189 allocated flu shots, with more to be available in December. Regarding the Community Awareness for All Committee, an open house was scheduled for Nov. 15 and all were invited.

POLICE AND RECREATION: Under Recreation, Commissioner Kistner reported the Haunted Hay Ride provided 650 rides and proved to be a wonderful event. Larger than ever sign ups were received for Basketball for boys and girls and for Wrestling. A Girls Softball Program will be under Little League for K-2nd grade. Traveling leagues are being formed for 3rd-8th grades. A Halloween Party for Seniors is scheduled for Wednesday, October 26, and the Ragamuffin Parade is October 29. Under Police, Commissioner Kistner thanked Lt. Archer, Sgt. Vargo, and Patrolman Ciccarelli for their assistance with the Haunted Hay Ride. He reported that two members of the

Bloods gang were in the area of Industrial Avenue with a stolen vehicle and a pursuit ensued resulting with one arrest in Little Ferry and one on foot. He commended Chief Colaneri, Captain Castiglione and Detective Rinke.

FIRE AND PARKS: Under Fire, Commissioner Meli, noting that Lt. Cirelli and Chief Ratkowski were present. There were 80 calls for the month of September, noting the Ambulance Squad volunteers rolled the ambulance almost three times per day, and including the fire calls, these volunteers went out four times a day. He noted that there were five plane crashes at Teterboro, and with some added pressure, the airport and Port Authority will be replacing their equipment with new to be better prepared, and a foam truck will be given to the borough by Port Authority at no cost to the borough. On November 19 a beefsteak dinner at the Elks Club will be held for the Pascagoula Fire Department. Over \$5,000 has already been sent. Under Parks, he congratulated Rob Brady, Commissioner Kistner and Al DeAngelo for the excellent Halloween in the Park. He noted Bill O'Shea is coming to Jefferson Avenue, Commerce Bank will be built on his location and the Garden Club will make a presentation regarding the Boulevard at the next Council meeting. He invited Michele Reutty, Library director, to speak on upcoming programs. She reported a grant for wireless laptops has been received, and 14 are now available. She signed a contract for placing 15 years of The Observer in digital format, beginning with 1894, in ten year increments. On January 1, 2005, mp3 files of recorded books will be available to be downloaded. Before the end of two years, music, games and videos will be available. The endowment fund donations are financing a good part of the wireless updates, and financed \$42,000. She reported former Governor Christine Todd Whitman will be coming November 22 at 1 p.m. to conduct a book signing. She was instrumental in library grants when in office. November 4 is Leggo Night, judged by Arcari & Iovino, (architects for the Municipal and Public Safety buildings) and November 5 a talk/concert on Frank Sinatra will be held with memorabilia courtesy of Mike Conti, a town resident.

SANITATION AND LAND USE: Under Sanitation, Commissioner Introna had no report (which he thought was due to the retirement of Supt. Heck), and will check on equipment for leaf pickup. He advised residents that if you choose to bag, it will assist in the pickup, and to place leaves in streets during the allotted time.

STREETS AND TRANSPORTATION: Under Streets and Transportation, Commissioner Skiba had no report (she noted due to the retirement of Supt. Heck.) Under Teterboro Airport, regarding charter service (an ad was discovered by members of the Coalition) offering regularly scheduled flights. She forwarded the information to Senator Corzine's office who sent a representative to Teterboro whom she learned was given a tour of the airport, and she also learned that with the construction of the arrestor beds, some hangars will be moved, that jets cannot stay and must come and leave again which could be an increase in air traffic.

MISCELLANEOUS FROM PUBLIC (cont'd):

Steven Schmidt, 643 Hackensack St., Carlstadt, the owner of 207 Franklin Avenue, was concerned about limited parking at his building site for tenants. His tenants questioned if stickers or alternate parking were available. He was told this has been looked into, and upon review, stickers were considered not an option, that the ordinance related to parking on commercial lots is being reviewed, and a moratorium on zoning enforcement of owners of commercial lots renting parking spaces is in effect until review is complete.

Michele Reutty, 189 Lincoln Avenue, Elmwood Park, Library Director, wished to remind residents of the Book and Bake Sale on November 19.

Sonya Buckman, 239 Central Avenue, questioned why the Council Minutes were not on the official website, and the clerk explained she had not transferred the files to the website as yet, and would check it out, that she did have copies in her office if needed.

A motion was made by Councilwoman Skiba, seconded by Councilman DiPisa to approve the Halloween Window Painting, and was unanimously carried.
