A Regular Meeting of the Mayor and Council of the Borough of Hasbrouck Heights was held on Tuesday, December 27, 2005 at 8:00 p.m. at Borough Hall, 320 Boulevard, Hasbrouck Heights, New Jersey.

Borough Clerk Rose Marie Sees stated that the meeting complied with the Sunshine Law, adequate notice of this meeting having been made to all members of the Council by personal service on January 4, 2005 and transmitted to The Observer, The Record and The Herald News on January 4, 2005.

REPORTS:

FINANCE AND SOCIAL SERVICES: Under Finance, Commissioner Link read the following Finance Report: The current fund cash balance as of November 30, 2005 was \$4,731,700.32; on October 31, 2005 was \$869,632.59 which represents an increase of \$869,632.59. The entire balance was invested and is earning 4.11%. Cash receipts for November totaled \$4,068,373.34 of which \$3,654,582.48 was for current taxes, \$21,978.51 was prior year taxes, \$18,374.61 for Prepaid 2006 Taxes, \$256,209.96 was grants and state aid and \$117,227.78 was miscellaneous revenues. Cash disbursements for November totaled \$3,208,810.60 of which \$1,473,969.42 was local school taxes, \$785,193 was county taxes, \$543,449.05 was salaries, and \$406,199.13 was for other expenses. He reported the Finance Officer is preparing the Annual Debt Statement due January 31, 2006 and Annual Financial Statement due February 10, 2006.

POLICE AND RECREATION: Councilman Kistner deferred his reports to the January 1 Reorganization Meeting.

FIRE AND PARKS: Commissioner Meli deferred his reports to the January 1 Reorganization Meeting. He noted this was Councilman Link's final council meeting, and thanked him for his inspiration.

SANITATION, LAND USE AND PUBLIC FACILITIES: There were no reports presented.

STREETS AND TRANSPORTATION: Councilwoman Skiba thanked Councilman Link for his many years of service to the community. Under Transportation, as Commissioner, she gave a brief report that the FAA and U.S. Department of Transportation have released their draft Environmental Impact Statement with regard to New York, New Jersey and Philadelphia air space redesigns. Written comments can be submitted until June 1, 2006 with a post public meeting scheduled for Hasbrouck Heights in April. More information will be provided at the January meeting. A meeting of the Coalition for Public Health and Safety will be held January 2 at 7:30 p.m. in Carlstadt, with meetings resuming there. Under Streets, she reported the DPW received a new John Deere Front End Loader with snow plow attachment and International Tree Truck, that the leaf removal program was delayed due to two early snowstorms. Leaves can no longer be raked into street, but bagged and/or placed in containers and left at curbside. She noticed the department is sweeping the streets and cleaning out storm drains. Residents were reminded to not shovel or blow snow

into streets. Several streets are scheduled for resurfacing and 40 trees scheduled to be planted in the fall will be added to the spring planting list.

Mayor Jones deferred his report to the Reorganization Meeting on January 1, and thanked Acting Supt. Spindler with regard to the past two snow storms. He reported "progress."

On a motion by Councilwoman Meli, seconded by Councilman Kistner, and unanimously carried, Ordinance Nos. 2113, 2114, 2115, 2116 and 2117 were approved.

On Ordinance No. 2118, the votes cast were Councilwoman Skiba voting Nay, Councilman Introna passed and then was asked if he wished to vote, and voted Nay; Councilman Link voting Nay, and Councilman Meli and Councilman Kistner voting Aye, causing this ordinance to be defeated.

MISCELLANEOUS FROM PUBLIC:

Mayor Jones opened the meeting to the public.

Janet Kretzdorn, 393 Church Street, questioned who was responsible for cleaning the sidewalk of leaves under the Route 46 overpass. She also questioned who was responsible for snow removal at the location where the bus shelter was removed. She was advised that theoretically, the owner of the property is responsible, but that the

DPW had been cleaning these areas. She was advised that the Department of Public Works will continue to clean these areas until the Borough Attorney and Acting DPW Supt. discuss this matter further. An area near the Route 46 overpass on Terrace Borough of Hasbrouck Heights - 12/27/05 - page 6

Avenue was also noted regarding pooling of rainwater. A request to clean any graffiti on bridges in Hasbrouck Heights was made by the Mayor.
