MISCELLANEOUS FROM PUBLIC:

Mayor Jones opened the meeting to the public for anyone wishing to speak:

Christine Tripp, 207 Franklin Avenue, questioned the situation regarding parking in parking lots overnight. She was advised that this body did request by motion at the last meeting that the Zoning Enforcement Officer withhold any action on the strict enforcement of that ordinance until the Zoning Committee can review the ordinance and make possible provision for additional parking on private lots. A meeting is scheduled for May 18.

Rose Heck, 501 Collins Avenue, as chairman of the Environmental and Transportation Commission, was requesting review of recycling promotion with DPW Supt. Heck. They were suggesting once or twice a year pickup of hazardous material preferably before the BCUA collections; renewal of the free mulch program and wood for fireplaces; and a tree planting space with the aid of volunteers. She asked what were the plans for leaf collection for 2005, the status of the cleaning of the East and West Riser Ditches, what plans for parks and sports fields, she was aware of the CD grant requests for Woodland Park. The commission would like input in the Central Avenue Park and ask for a tree, gazebo and bench to be placed there in honor of former deceased DPW Supt. James Cotter. They also recommended a portion be dedicated as a children's reading garden. The Environmental Commission sponsored a poster contest for children K-5, and were requesting formal presentation of awards at the next Council Meeting. A suggestion to apply for a DEP grant was made. On Transportation, the Commission would like to work on several projects including bus and pedestrian safety, establishing the possibility of a railroad station and park and ride, in conjunction with Teterboro at Route 17 and Williams Avenue.

Mayor Jones noted Woodland Park is in the process of clean up. DPW Foreman James Schneider reported the mulch program was stopped as trees were dead and diseased. Mayor Jones asked to look into possibly a spraying program to salvage some of the wood. Regarding hazardous waste collection, Mr. Schneider will check with the county for transportation of hazardous materials. It was suggested that DPW Supt. Heck and Foreman Schneider attend an Environmental Commission meeting. Councilman Kistner reported on grant monies for a basketball/skating rink facility and softball field. Councilwoman Skiba gave an update on Riser Ditch as well as Engineer Job. Mayor Jones invited the commission to be part of the Central Avenue Park. He commended John Stavash for his expertise, and Colleen Jarvis from the Commission.

Anthony Grasso, 215 Hamilton Avenue, who lived next to Carrino's parking lot presented pictures taken at night where cars are coming in and out all night long and he felt he was the only one affected.

The borough attorney asked to refer these pictures to the Zoning Committee.

MISCELLANEOUS FROM PUBLIC (cont'd):

Christine Tripp, 207 Franklin Avenue, questioned if this was a disagreement among neighbors, would this affect other lots. She was advised that the zoning committee would look at the ordinance borough wide.

Mark Barbe, 192 Boulevard, has lived at this address 15 years, and on Hamilton for 30 years, who lives across the street from the parking lot where he also parks his car. He had no problem with Mr. Carrino and had a totally different experience.

RECESS FOR WORK SESSION:

Mayor Jones announced that the meeting would be recessed for Work Session, to which he invited all present to stay.

ADJOURN:

There being no further business to be conducted by the Mayor and Council, the meeting was adjourned at 9:13 p.m.
