A Regular Meeting of the Mayor and Council of the Borough of Hasbrouck Heights was held on August 9, 2005 at 8:13 (ar p.m. at the new Municipal Building, 320 Boulevard, Hasbrouck Heights, NJ.

NEW BUSINESS

CONSENT AGENDA: None

RESOLUTIONS: 133. Amendment to 2005 Budget

Councilman Link read a prepared budget message as follows:

"The original 2005 municipal budget was introduced on March 8, and in light of the tax increase as proposed of 10.3 points we applied for Extraordinary aid in the amount of \$600,000 to offset the increase. We recently received word that the Borough would receive \$150,000 under this program.

"While waiting for the award of funding under this aid package the budget committee continued to meet in an effort to make further adjustments that would reduce the tax Borough of Hasbrouck Heights - 8/9/05 - page 3

increase as introduced. These meetings resulted in an additional \$326,219 reduction in the amount to be raised by taxes.

"The combination of increased revenues in the amount of \$365,000, and budget cuts in the amount of \$111,219.13, has resulted in an Amount to be Raised by Taxes for the Local Budget of \$10,326,311.87. This is \$476,219 less than the Amount to be Raised by Taxes for the Local Budget s introduced in March. We have been able to cut 5.5 tax points off of the budget as introduced.

"Based on the budget amendment being adopted tonight the average house assessed at \$195,000 would pay \$2,299.05 in Local Taxes in 2005 as compared to \$2,205.45 last year, this represent an increae of \$93.60 in Local Taxes. The total tax bill cannot be determined until the Tax Board certifies the total rate. The budget will be transmitted to the Division of Local Government Services for approval and certification. We anticipate that tax bills will be printed and mailed within the next few weeks."

PUBLIC HEARING ON BUDGET AMENDMENT:

Mayor Jones opened the meeting to the public on the Amendment to the 2005 budget.

Michael Maginley, 110 Jefferson Avenue, requested clarification on the local budget increase, if this did not include the school budget, which he was told it wasn't. He requested an estimate, and CFO Michael Kronyak estimated 15 points including county and school taxes.

On a motion by Councilman DiPisa, seconded by Councilman Kistner, and unanimously carried, the foregoing Resolution was approved (Copy attached).
