MINUTES

December 28, 2006

A Regular Meeting of the Mayor and Council of the Borough of Hasbrouck Heights was held on Thursday, December 28, 2006 at 8:08 p.m. at Borough Hall, 320 Boulevard, Hasbrouck Heights, New Jersey.

Borough Clerk Rose Marie Sees stated that the meeting complied with the Sunshine Law, adequate notice of this meeting having been made to all members of the Council by personal service on January 3, 2006 and transmitted to The Observer, The Record and The Herald News on January 3, 2006.

On a motion by Councilwoman Saccomano, seconded by Councilman DiPisa, and unanimously carried, the foregoing Resolution was adopted.

REPORTS:

HEALTH AND PARKS: Under Health, Commissioner DiPisa reported Taco Bell Restaurant continued to remain closed on a voluntary basis. The Board of Health has been monitoring the disinfection and germicidal cleanup of their operation. Under Parks, he reported the installation of the handicapped facilities at Woodland Park will begin in the next four to six weeks.

POLICE AND RECREATION: Commissioner Kistner requested to hold his reports for Police and Recreation until January 1, 2007.

FINANCE AND FIRE: Commissioner Meli requested to hold his reports for Finance and Fire until January 1, 2007.

SANITATION AND PUBLIC FACILITIES: Under Sanitation, Commissioner Introna reported that \$26,000 was saved by the DPW in its leaf program, a result of dumping leaves by putting them in trucks with compaction, including a savings of \$2,000 in gas and \$4,000 in overtime. He thanked Bruce Bonaventuro from Bergen County for his expert advice.

TRANSPORTATION AND SOCIAL SERVICES: Commissioner Skiba requested to hold her reports on Transportation and Social Services until January 1, 2007. Borough of Hasbrouck Heights - 12/28/06 - page 4 **STREETS AND LAND USE:** Under Land Use, Councilwoman Saccomano read the Property Maintenance reports for November and December. Nine complaints by neighbors with issues resolved, four stop orders to contractors for working past the allotted time, six verbal warnings for blowing leaves into streets, eight shop owners were informed to clear their sidewalks, one fine to a resident for signing a construction permit and hiring a contractor, four violations notices for property maintenance. December report included four summons heard in municipal court on November 29, one final warning to a resident conducting auto repair work in the backyard, three warnings to parking vehicles on lawns, three property maintenance violations, four warnings for placing leaves on curb without bagging, one placing garbage on the curb too early. She reported the Building Department for December issued 56 permits totaling \$12,117, for November 67 permits totaling \$9,572. She recited Section 303.3 of the International Property Maintenance Code which states address numbers should be visible on buildings including special criteria.

REPORT OF MAYOR: Mayor Jones reported progress. He congratulated the DPW for saving \$26,000 in the leaf program and thanked the members of the Building Department for their efficiency.

Mayor Jones opened the public hearing on Ordinance Nos. 2148, 2149, and 2150.

Juan Hernandez, 415 Springfield Avenue, on Ordinance No. 2150 was concerned how the current ordinance has been working for 122 years without any problems, and all of a sudden amendments are done to it, that in his opinion people should work together as a team and continued that the real issues should be dealt with such as higher taxes.

Councilwoman Saccomano, regarding Ordinance No. 2150, thought the wording "appointing authority" was vague and thought the ordinance cumbersome. The borough attorney explained that the appointing authority is whoever is head of that authority, it could be the head of that board, the governing body, etc., that this ordinance provides a way for who has the authority to appoint has a place to go to see who is interested in that appointment and provides an opportunity for those who are interested to make that interest known. It also provides an opportunity for a person who is not interested in a reappointment to make that known. The information would include name, address, telephone number, a little background and special qualifications and be kept on file for two years. Councilman Introna questioned where pay to play tie into this, and the borough attorney explained it simply codifies what currently exists.
