### ORDINANCE NO. 2129:

BE IT RESOLVED that an Ordinance entitled: "AN ORDINANCE TO SUPPLEMENT SUBSECTION M WHICH PROHIBITS CABARETS AND NIGHTCLUBS IN CERTAIN AREAS AS THE SAME IS CONTAINED IN §275-20 ENTITLED "REGULATIONS GOVERNING CERTAIN PRINCIPAL USES" OF CHAPTER 275 ENTITLED "ZONING" OF THE CODE OF THE BOROUGH OF HASBROUCK HEIGHTS SO AS TO EXEMPT FROM THAT PROHIBITION CERTAIN LIMITED ENTERTAINMENT BY LIVE PERFORMERS WHEN CONDUCTED AS AN ACCESSORY TO CERTAIN PERMITTED USES IN THE B-1 CENTRAL BUSINESS DISTRICT AND THE B-2 HIGHWAY COMMERCIAL DISTRICT" be now passed on second and final reading and the Borough Clerk be and is hereby authorized and directed to publish said Ordinance, same to be published in The Observer, a newspaper circulating and published in the Borough of Hasbrouck Heights.

### **MISCELLANEOUS FROM PUBLIC:**

Mayor Jones opened the meeting to the public.

Shirley Benson, 14 Garrison Avenue, questioned the re-zoning of the property directly behind her residence, and if the some of the trees might remain for privacy and shade. She was advised that this will be referred to the Planning Board when the subdivision is requested.

John Goehrig, 262 Lawrence Avenue, questioned when there would be a Bulletin Board in front of the Municipal Building. He also requested that a sign announcing a traffic light be installed on Route 17 South at the Williams Avenue approach.

Dorothy Checki, 214 Coolidge Avenue, regarding the tree in front of her house, whether it will be taken down as she has had many problems with it, including the sidewalk rising. PSE&G had come and told her they would be cutting the tree down half way, with the DPW removing the rest of the tree. She also referred to other tree problems on this street. She was invited to remain for the Work Session where more discussion of this would be done.

Edward Sees, 47 Wood St., questioned the governing body as to the allegation that borough employees work shorter hours in the summer.

Councilwoman Saccomano thanked the DPW and Police Academy participants for fixing Terrace Avenue and the handicap ramp to the Veterans Memorial, with the Mayor and Councilman DiPisa concurring. Borough Engineer Ken Job was also thanked.

There being no one else wishing to speak, the public portion was closed.

Mayor Jones announced that the meeting would be recessed for Work Session, to which he invited all present to stay.
