Councilwoman Skiba questioned Resolution Nos. 90, 91 and 92, how scholarships were determined. She was told that the high school sends applications from the children and are reviewed by the mayor, administrator and borough clerk.

Councilman Meli questioned if Resolution No. 96 was a revenue generating agreement and was told it is a reimbursement based on the number of miles of county roads plowed.

ORDINANCE(S) ON PUBLIC HEARING:

Mayor Jones opened the public hearing on Ordinance No. 2134. There being no one wishing to speak, the Public Hearing was closed.

ORDINANCE NO. 2134:

BE IT RESOLVED that an Ordinance entitled: "AN ORDINANCE TO APPROPRIATE THE SUM OF \$75,000.00 TO PROVIDE FOR THE ACQUISITION OF UPGRADED COMPUTER SOFTWARE AND HARDWARE FOR THE USE OF THE POLICE DEPARTMENT AND VARIOUS ADMINISTRATIVE OFFICES OF THE BOROUGH OF HASBROUCK HEIGHTS, TO APPLY AN ENHANCED 9-1-1 GENERAL ASSISTANCE GRANT FROM THE OFFICE OF INFORMATION TECHNOLOGY OF THE STATE OF NEW JERSEY IN THE SUM OF \$17,800.00 TO THE COST THEREOF, TO FURTHER APPROPRIATE THE SUM OF \$5,250.00 FROM THE CAPITAL IMPROVEMENT FUND AS THE DOWN PAYMENT, AND FURTHER TO AUTHORIZE THE FINANCING OF THE BALANCE OF THE COST THEREOF IN ACCORDANCE WITH THE PROVISIONS OF THE LOCAL BOND LAW BY THE ISSUANCE OF BONDS OR NOTES NOT TO EXCEED THE SUM OF \$51,950.00" be now passed on second and final reading and the Borough Clerk be and is hereby authorized and directed to publish said Ordinance, same to be published in The Observer, a newspaper circulating and published in the Borough of Hasbrouck Heights.

On a motion by Councilman Meli, seconded by Councilwoman Saccomano, and unanimously carried, the foregoing Ordinance on Public Hearing was approved.
