**HEALTH AND PARKS:** Under Health, Commissioner DiPisa reported for the month of July there were 16 births, 9 male, 7 female, 81 burial permits, 2 from Hasbrouck Borough of Hasbrouck Heights - 8/22/06 - page 5

## **HEALTH AND PARKS (cont'd):**

Heights, 564 certified transcripts, 20 marriages, collected in fees \$10,962. On August 15, a special meeting was held to appoint a new registrar/secretary for the Board of Health with the retirement of Marilyn deRussy. They unanimously appointed Lori French to begin on September 2, 2006. The 4<sup>th</sup> Health Fair Expo will be held on Oct. 13, 2006 in the Senior Center and all residents are invited. Under Parks, he complimented the DPW on the improvements to the Soccer Field in Woodland Park. Under Community Awareness Access to All, he reported new members are welcome to an open house on Sept. 5. He and Councilwoman Saccomano had met on August 9 and 16 with Construction Official Nick Melfi to discuss options for apartment resident parking and options for driveways.

POLICE AND RECREATION: Under Recreation, Councilman Kistner said over 75 children are signed up. College students have been hired as chaperones. The final concert is scheduled for August 24 featuring "Boote." Recreation Director Rob Brady and Jennifer Catalano will be getting married August 25 and he wished them well. Under Police, the Junior Police Academy finished on August 21. He thanked Middle School Teacher Michael Stillman, Det. Joseph Rinke, Det. Michael Colaneri Jr., Capt. Jack DeLorenzo and Capt. Bill Castiglione and Patrolman Alan Baker.

FINANCE AND FIRE: Under Finance, Commissioner Meli read the following Finance Report: the Current Fund cash balance at July 31, 2006 was \$470,804.45 and at June 30, 2006 was \$584,802.28 which represents a decrease of \$113,997.83. The entire balance was invested and earning approximately 5.25%. Cash receipts for the month of July totalled \$2,773,802.91 of which \$2,583,499.79 was for Current Taxes, \$30,039.77 was for Delinquent Taxes, \$46,119.00 was Grants and Aid and \$114,144.35 was Miscellaneous Revenues. Cash disbursements for the month of July totaled \$2,887,800.74 of which \$1,586,924.83 was Local School Taxes, \$568,464.03 was for Salaries and \$732,411.88 was for Other Expenses. He continued by reading the following statement:

# STATEMENT FOR INTRODUCTION AND ADOPTION OF 2006 BUDGET AMENDMENT

"Tonight we are introducing an amended 2006 Municipal Budget.

"The original 2006 municipal budget was introduced on March 21st, and in light of the tax increase as proposed of 6.1 points we applied for Extraordinary Aid in the amount of \$650,000.00 to offset the increase. We recently received word that the Borough would receive \$150,000.00 under this program.

"While waiting for the award of funding under this aid package the budget committee continued to meet in an effort to make further adjustments that would reduce the tax

increase as introduced. These meetings resulted in an additional \$398,895.00 reduction in the amount to be raised by taxes.

"The combination of increased revenues in the amount of \$352,097.00, and budget cuts in the amount of \$196,798.00, has resulted in an Amount to be Raised by Taxes for the Local Budget of \$11,065,348.41. This is \$548,895.41 less than the Amount to be Raised by Taxes for the Local Budget as introduced in March. We have been able to cut 3.3 tax points off of the budget as introduced.

"In order to make the budget cuts every line item was examined and the expenditures to date were considered. Ultimately 39 separate operating line items received cuts with the smallest cut being \$500.00 and the largest cut being \$17,500.00.

"Based on the budget amendment being introduced tonight the average house assessed at \$436,800.00 would pay \$2,603.32 in Local Taxes in 2006. The total tax bill cannot be determined until the County Tax Board certifies the total rate. After the public hearing on this amendment is held on August 29, 2006, at 8:00 pm, here in the Municipal Building, the budget will be transmitted to the Division of Local Government Services for approval and certification. We anticipate that final tax bills will be printed and mailed within the next few weeks." Under Fire, he reported that he had met with the local Clergy and Councilwoman Saccomano to discuss the 9-11 Memorial which will be held on September 11. The theme would be to honor first responders from Hasbrouck Heights. The Firemen's Memorial Program is ongoing and brick orders are being received.

**SANITATION AND PUBLIC FACILITIES**: Under Sanitation, Commissioner Introna reported the DPW has completed maintenance of the Borough's sanitary sewer line that runs underneath and parallel to Route 17. A collapse in the line along the northbound section was discovered caused by a telephone pole that settled. This is now in the hands of the Borough engineer.

**TRANSPORTATION** AND SOCIAL SERVICES: Under Social Services. Councilwoman Skiba reported donations were received from the Masonic Lodge, Dorothy and Aimee McCarthy and Meredith Yorkin who donated items and helped man the pantry during June and July, Nancy Nimmo, Gina DeFlorio, St. John's Episcopal Church, Corpus Christi's Brown Bag Sunday, First Reformed Church, Bertha Spada, and Dorothy Petroulis. Under Transportation, she reported Environ Corportation in conjunction with Dr. Artegas who is conducting an environmental impact study of the Meadowlands is looking for volunteers to wear 48-hour monitoring devices. Councilwoman Skiba is coordinating the effort and can be reached at 201-288-7448 and for the first round badges would need to be picked up Aug. 26 or Sept. 7.

STREETS AND LAND USE: Under Streets, Councilwoman Saccomano reported the DPW is awaiting notification of a start date from the County for the repair of Terrace Borough of Hasbrouck Heights - 8/22/06 - page 7

Avenue from Springfield to Pasadena Avenues, with utility companies doing repairs. Trees that need to be addressed have been put on a list as a result of storms in July. Under Land Use, she reported that in July the Building Department issued 57 building permits. She read into the record hours of operation for contractors as follows: Monday thru Friday from 7:30 a.m. to 5 p.m., Saturday from 8 a.m. to 1 p.m. and absolutely no contractors or landscapers are permitted to work on Sunday. Homeowners if doing the work yourself can work Monday thru Friday from 7:30 a.m. to sunset, Saturday from 8 a.m. to sunset and Sunday from 10 a.m. to sunset. Certificates of occupancy are required for sale of property. She reported Councilman DiPisa, Mr. Melfi and she had met regarding parking lots in the B-1 District Zone. They also reviewed an outline presented by Mary Ellen Courtney on real estate signs, and reviewed the decks requirements.

## **NEW BUSINESS:**

## JUVENILE DETENTION CENTER IN TETERBORO:

Councilwoman Saccomano asked to make a recommendation under New Business regarding the proposed Juvenile Detention Center to be placed in Teterboro, and requested if the Mayor and Council could write a letter to the Board of Chosen Freeholders that this be put on the ballot for a referendum in November, and write letters to the surrounding towns if they would do the same.

Councilwoman Skiba had spoken with Councilman Mauro Raguseo of Little Ferry whose police department covers Teterboro, who had suggested the communities get together and discuss ideas. She reported she had attended a Freeholder meeting last week at which they introduced a \$9.8 million bond ordinance for this project which did not include design costs or construction with only Freeholder Elizabeth Randall voting no.

Councilwoman Saccomano referring to Former Mayor and Assemblywoman Rose Heck who had also attended that meeting and who asked if she should rise for a point of information as she had intended to speak on this in the public portion, said she was Borough of Hasbrouck Heights - 8/22/06 - page 8

most concerned that they are doing this without a traffic study or environmental study and that a resolution be introduced to request such from the Freeholders before passage of this ordinance. She additionally noted public transportation is no where near that particular area so they will be coming in and around the surrounding towns, that a number of people have requested that they take the juvenile center they have now and leave it on Paramus ground and just do it there. It is incumbent upon Hasbrouck Heights, Little Ferry, South Hackensack, all the adjoining towns to request pertinent information.

Councilman Meli wholeheartedly agreed, as Hasbrouck Heights covers the ambulance for Teterboro, that there are additional procedures that our volunteers would have to get involved in that regard.

Councilman DiPisa said they should rethink this, from a cost point of view it sounds so prohibitive to go somewhere else, when you can just expand where you are and he was shocked that the adjacent towns did not had an opportunity to respond.

Mr. Meli recommended it be done through resolution and agreed with Councilwoman Skiba as to a presentation also.

Mayor Jones asked if Teterboro had been consulted.

Borough Attorney Chandless said the difficulty is that we would have to extract the language from the Minutes tonight. Rather than try to dispatch a verbatim resolution, he suggested authorizing Mrs. Sees and himself to extract the pertinent language from the record this evening and advise the freeholders of that with copies to Township of South Hackensack, Borough of Little Ferry, Borough of Teterboro, Borough of Moonachie. Copies should go to the Governor, Senator Coniglio, Assemblyman Gordon and Assemblywoman Voss. A motion was made by Councilman Meli, to put together a notice to the Bergen County Freeholders, seconded by Councilwoman Skiba. A roll call resulted in a unanimous affirmative vote. A suggestion was made to make the language strong.

A recommendation was made to have the entire council attend the next public meeting of the Freeholders.

## **MISCELLANEOUS FROM PUBLIC:**

Mayor Jones opened the meeting to the public for anyone wishing to speak.

Gilbert Hunt, 117 Henry Street, spoke on budgets, taxes, the Juvenile Detention Center, and government procedures, that the entire council support some kind of budget. He

Mayor Jones noted many hours went into the preparation of the budget by the Finance Committee and agreed full council support was needed, and later expressed that full disclosure was provided to the council.

Councilman Introna said the issue is saving taxes, that he was offended that the Superintendent (of Schools) wasn't present (when the school budget was discussed) to answer some questions he had of possibilities to save money and that was why he voted no on the school budget.

Councilman Meli as a member of the Finance Committee had repeatedly requested any council member approach him with ideas, recommendations and questions, but received none, until tonight.

Councilwoman Saccomano did not discredit the Finance Committee, but found it disheartening that people are selling their homes as they can't pay taxes, and voted no.

Councilman DiPisa said the council had the opportunity to review every line item. There was \$200,000 cut. If he had a question he would be proactive in finding an answer.

Ronald Ellis, 107 Paterson Avenue, who was on the Board of Education for six years, was surprised on the vote of the budget and what followed, noting the BOE budgetary process, the procedure and time lines for special needs students. He was present to again request the bus stop at Paterson Avenue and the Boulevard be revisited as he had proposed in 2003, referring to some proposed changes regarding bus stops on the Borough of Hasbrouck Heights - 8/22/06 - page 12

## **MISCELLANEOUS FROM PUBLIC (cont'd):**

Boulevard which would prove even more inconvenient. Chief Colaneri would sit down with Mr. Ellis and listen to his suggestions.

Steven Altobelli, 67 Hamilton Avenue, asked for an update on Depken Field improvements. He was told that receipt of environmental reports was pending. Committee meetings on ongoing. A 501C3 corporation was being set up for donations. No action could take place until the sale of the property.

Anthony DiNanno, 10 Garrison Avenue, questioned the field project, if there was a set time for breaking ground. He was told it was all premised on the closing of the property. Martin Saccomano, 57 Ottawa Avenue, had attended the Kiwanis meeting who had approved a donation to a special program for Alzheimer's patients monitored by the B.C. Sheriff's Department and hoped all town clubs would donate to this program.

There being no one else wishing to speak, the public portion was closed.
