ORDINANCE NO. 2152:

BE IT RESOLVED that an Ordinance entitled: "AN ORDINANCE TO AMEND SECTION 275-16 ENTITLED "YARD REGULATIONS" OF CHAPTER 275 ENTITLED "ZONING" OF THE CODE OF THE BOROUGH OF HASBROUCK HEIGHTS AND TO SUPPLEMENT SUBSECTION A ENTITLED "ACCESSORY STRUCTURES AND USES IN RESIDENTIAL DISTRICTS" OF SECTION 275-21 ENTITLED "REGULATIONS GOVERNING CERTAIN ACCESSORY STRUCTURES AND USES" OF CHAPTER 275 ENTITLED "ZONING" OF THE CODE OF THE BOROUGH OF HASBROUCK HEIGHTS SO AS TO ALLOW DECKS THAT EXCEED A HEIGHT OF THREE FEET OVER THE NATURAL GRADE UNDER CERTAIN LIMITED CIRCUMSTANCES" be now passed on second and final reading and the Borough Clerk be and is hereby authorized and directed to publish said Ordinance, same to be published in The Observer, a newspaper circulating and published in the Borough of Hasbrouck Heights.
