# **ORDINANCE NO. 2159:**

Borough of Hasbrouck Heights - 7/10/2007
BE IT RESOLVED that an Ordinance entitled: "AN ORDINANCE TO APPROPRIATE THE SUM OF \$190,000.00 TO PROVIDE FOR THE ACQUISITION OF GEAR AND EQUIPMENT FOR THE USE OF THE FIRE DEPARTMENT OF THE BOROUGH OF HASBROUCK HEIGHTS AND TO FURTHER AUTHORIZE THE FINANCING OF THE COST THEREOF IN ACCORDANCE WITH THE PROVISIONS OF THE LOCAL BOND LAW BY THE ISSUANCE OF BONDS OR NOTES NOT TO EXCEED THE SUM OF \$180,000.00" be now passed on second and final reading and the Borough Clerk be and is hereby authorized and directed to publish said Ordinance, same to be published in The Record, a newspaper circulating in the Borough of Hasbrouck Heights.

On a motion by Councilwoman Skiba, seconded by Councilman DiNanno, and unanimously carried, the foregoing Ordinance on Public Hearing was approved.

#### MISCELLANEOUS FROM PUBLIC:

Council President Introna invited anyone wishing to speak, to please come forward.

Helayne Weiss, 315 Charlton Avenue, questioned Councilman Introna as Finance Commissioner and what had been done regarding the budget, extraordinary aid for this year and last year, if there would be an increase in taxes if no aid was received, where cuts were made so far, where the increases were coming from, what disbursements were authorized thus far with Depken Field, if expenditures should be authorized by the council. She also questioned the Task Force's authorization for the removal of trees and the difference in costs if the trees had been removed during the work week versus the weekend. She requested minutes of the Task Force meetings and Finance Committee meetings. If minutes were required of committee meetings was discussed.

Theresa Call, 231 Paterson Avenue, questioned the water outside of Euclid School. United Water would be contacted. She complimented the DPW on the care of the roads and the garbage trucks not spilling debris on the roads. She asked if union members could be part of the specifications for municipal contracts. She was advised that the contractor and the union had come to an agreement, and that the public contracts law requires prevailing wage. She asked if soil would be tested before it is brought into the town for the Depken Field. She was told that no soil would be brought into the site.

Robert Call, 231 Paterson Avenue, remarked that the meeting was peaceable.

There being no one else wishing to speak, Council President Introna closed the public portion.

Council President Introna announced that the meeting would continue to Work Session, to which he invited all present to stay.
