MINUTES

January 13, 2009

A Regular Meeting of the Mayor and Council of the Borough of Hasbrouck Heights was held on January 13, 2009 at 8:06 p.m. at Borough Hall, 320 Boulevard, Hasbrouck Heights, NJ.

MISCELLANEOUS FROM PUBLIC:

Mayor Heck requested a motion to open the meeting to the public which was made by Councilman DiNanno, seconded by Councilman DiPisa, and unanimously carried.

Christian Semenecz, 415 Jefferson Avenue, regarded construction and his concerns from October. He recently had approached Mr. Melfi about a complaint he had regarding a construction problem who advised him he should have called the Police Department. Chief Colaneri concurred, that after hours a resident should call the Police and if it was not an emergency, in turn would refer it to Mr. Melfi, that there are procedures to follow.

MISCELLANEOUS FROM PUBLIC (cont'd):

Robert Parisi, 326 Hamilton Avenue, questioned the removal of parking on the south side of Hamilton Avenue and if there were any statistics. It was explained that this was done by ordinance which was duly advertised, and that the Fire Department had requested this for safety reasons. The Police Department did a study and concurred. It was noted this had been under consideration for some time, and there is an increase in the size of fire apparatus. Mr. Parisi was concerned about parking of his own vehicles, and was referred to the Borough Clerk for overnight parking provisions. He was also concerned with diminished value of his home. Mayor Heck suggested using the town parking lot and that he meet with Borough Clerk Ro Sees.

There being no one else wishing to speak, Mayor Heck asked for a motion to close the public portion which was made by Councilman DiPisa, seconded by Councilman DiNanno, and unanimously carried.

WORK SESSION:

Mayor Heck announced that the meeting would continue to Work Session, to which she invited all present to stay. On a motion by Councilman Gonzalez, seconded by Councilman DiPisa, and unanimously carried, this motion was carried.

ADJOURN:

There being no further business to be conducted by the Mayor and Council, the regular meeting was adjourned at 9:20 p.m.
