MINUTES

October 13, 2009

A Regular Meeting of the Mayor and Council of the Borough of Hasbrouck Heights was held on October 13, 2009 at 8:04 p.m. at Borough Hall, 320 Boulevard, Hasbrouck Heights, NJ.

Mayor Heck declared the meeting in Session and Borough Clerk Rose Marie Sees stated that the meeting complied with the Sunshine Law, adequate notice of this meeting having been made to all members of the Council by personal service on January 5, 2009 and transmitted to The Observer, The Record and The Herald News on January 5, 2009.

SALUTE TO THE FLAG AND PLEDGE OF ALLEGIANCE: Council President Buckman led in the Salute to the Flag and Pledge of Allegiance.

INVOCATION: The Invocation was given by Councilman David Gonzalez as follows:

"May today be all that you need it to be. May the peace of God and the freshness of the Holy Spirit rest in your thoughts, rule in your dreams tonight and conquer all your fears. May God manifest himself today in ways you have never experienced. May your joys be fulfilled, your dreams be closer and your prayers be answered. I pray that faith enters a new height for you and I pray that your territory is enlarged. Amen."

PRESENTATION: The Woman's Club of Hasbrouck Heights presented a gift of two GPS' to the Hasbrouck Heights Fire Department

Presentations included a gift of two GPS to be used in Fire Department ambulances and a framed tablecloth which had engraved in needlepoint the names of all Woman's Club members since its inception in 1922 to the present. The GPS were presented to Fire Chief Michael Ratkowski and Ambulance Squad Captain Elizabeth Waring.

PROCLAMATION: Put the Brakes on Fatalities Day® October 10, 2009

WHEREAS, across the nation, traffic crashes caused nearly 40,000 fatalities in 2008, and are the leading cause of death for young people ages 3 to 34; and

WHEREAS, in New Jersey, 591 individuals lost their lives in traffic crashes in 2008; and

WHEREAS, Alcohol-related crashes accounted for 26 percent of the State's traffic fatalities; and

WHEREAS, unsafe speed was a factor in more than 22,000 crashes; and

WHEREAS, motorcyclists, bicycle riders and pedestrians face increased risks on New Jersey's roadways, as people opt for alternative modes of transportation; and

WHEREAS, 78 motorcyclists, 21 bicyclists and 135 pedestrians were killed in New Jersey in traffic-related crashes in 2008; and

WHEREAS, safer driving behaviors such as buckling up every ride; obeying posted speed limits; avoiding aggressive driving behaviors; never drinking and driving; wearing proper safety gear when riding a motorcycle or bicycle; and, focusing solely on driving by avoiding distractions, can dramatically reduce the number of traffic-related injuries and deaths on our roadways;

NOW, THEREFORE, BE IT RESOLVED that I, Mayor Rose Heck of Hasbrouck Heights, New Jersey do hereby proclaim October 10, 2009, *Put the Brakes on Fatalities Day*®, and call upon everyone to put these lifesaving behaviors into practice to improve safety on the roadways in our community and throughout the State.
