MISCELLANEOUS FROM PUBLIC (cont'd):

Blanca Ortiz, Stephanie Ward and James Keenan of 150 Terrace Avenue were spokespersons for the 12 residents of this apartment building who were present due to no parking available at their building or in the vicinity and what could be done for them. They said the former hospital site was no longer providing parking for this building. Some of them were parking at the athletic field which was a seven block walk and only during certain hours. Ms. Ortiz had received a copy of the businesses who might provide parking, but this did not work out. Most of them became tenants in November and December. They were advised that if they were not given notice by the landlord that there was no parking available which was required, they should think about consulting with an attorney, that they might have a civil cause of action against the landlord due to breach of lease.

There being no one else wishing to speak, Mayor Heck asked for a motion to close the public portion which was made by Councilman Altobelli, seconded by Councilman DiNanno, and unanimously carried.

WORK SESSION:

Mayor Heck announced that the meeting would continue to Work Session, to which she invited all present to stay. On a motion by Councilman DiPisa, seconded by Councilman DiNanno, and unanimously carried, this motion was carried.

ADJOURN:

There being no further business to be conducted by the Mayor and Council, the meeting was adjourned at 9:04 p.m.
