ORDINANCE NO. 2214 (cont'd):

BE IT RESOLVED that an Ordinance entitled: "AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 181 ENTITLED MOTOR VEHICLE SALES, LICENSING," OF THE CODE OF THE BOROUGH OF HASBROUCK HEIGHTS WHICH REQUIRES THE ISSUANCE OF A LICENSE FOR THE COMMERCIAL SALE OF CERTAIN MOTOR VEHICLES, WHICH SETS FORTH THE REQUIREMENTS FOR SUCH LICENSE AND WHICH PROVIDES FOR THE IMPOSITION OF A FEE FOR THE SAME" be now passed on second and final reading and the Borough Clerk be and is hereby authorized and directed to publish said Ordinance, same to be published in The Observer, a newspaper published and circulated in the Borough of Hasbrouck Heights.

Salvatore Altomare, 123 Walter Avenue, accompanied Mr. Khorrami, as he was not aware of the rules and regulations and needed interpretation. The Court process was explained.

There being no one else wishing to speak, Mayor Heck asked for a motion to close the public portion which was made by Councilman DiPisa, seconded by Councilman Altobelli, and unanimously carried.
