ORDINANCE(S) ON CONTINUED PUBLIC HEARING:

ORDINANCE NO. 2267:

Mayor Heck requested a motion to open the public hearing on Ordinance No. 2267 which was made by Councilwoman Link, seconded by Councilman Gonzalez, and unanimously carried.

Andy Gamble, Post Commander of VFW Post #4591, questioned the ordinance as it related to no parking of vehicles after 8 a.m. Borough Attorney Chandless said this was the ordinance that permits rental of parking spaces to others and the rentals were limited to 6 p.m. and 8 a.m. Cars for the activity of the premises were permitted at any time. Mr. Gamble said he disagreed, that renters should be allowed to park during the day also.

Judi Ferrari, 117 Baldwin Avenue, read the article in the paper and the comments of the Planning Board, one being screening in the Central Business District zones next to a residential zone. She was advised by Mayor Heck that this was a recommendation that she knew of no action being considered. Ms. Ferrari was also concerned that noise will increase and was under the impression that this was for automobiles. The Borough Attorney said size was limited and the Zoning Enforcement Officer had discretion of where the parking will be, to be the least burden to the residents.

Marlene Verrastro, 117 Oldfield Avenue, was happy to hear that this ordinance was being added to, especially commercial vehicles and trailers.

Carol Skiba, 191 Field Ave., apologizing and saying she should have asked this question on the introduction of Ordinance #2267, asked if the Section number would be corrected, as the Planning Board Engineer at the Planning Board hearing noted this number was already used. The Borough Attorney said it had not been brought to his attention, and that it had no impact at all, and would be coded properly by the Code company.

There being no one else wishing to speak, Mayor Heck asked for a motion to close the public portion which was made by Councilman DiPisa, seconded by Councilwoman Link, and unanimously carried.
