"WHEREAS, Juliette "Daisy" Gordon Low was searching for something useful to do with her life and in 1911, and after meeting Sir Robert Baden-Powell in England, founder of the Boy Scouts and Girl Guides, she became interested in this new youth movement and less than a year later returned to the United States, and on March 12, 1912, Juliette assembled 18 girls from Savannah Georgia to register the first troop of American Girl Guides, with the name of the organization changed to Girl Scouts the following year; and

WHEREAS, in developing the Girl Scout movement in the United States, Juliette brought girls of all backgrounds into the out-of-doors, giving them the opportunity to develop self-reliance and resourcefulness, and possible future roles as professional women, and welcomed girls with disabilities at a time when they were excluded from many other activities; and

WHEREAS, from the 18 girls, Girl Scouting has grown to 3.7 million members and is the largest educational organization for girls in the world, and more than 50 million women in the United States today are Girl Scout alumnae; and

WHEREAS, from 1918 through 1921, the Pine Tree Troop of Girl Scouts was active in Hasbrouck Heights comprised of high school students organized into one troop with patrols made up of each class, and the oldest registration for a charter for Hasbrouck Heights Girl Scouts was found in Girl Scout National Headquarters in New York City, dated October 19, 1926; and

WHEREAS, Girl Scout Troops in Hasbrouck Heights presently registered under Girl Scouts of Northern New Jersey include Daisy Troop Nos. 94703, 94745, 94750, 94767, 95218, 95291; Brownie Troop Nos. 60454, 60463, 60517, 60522, 94308, 94414; Junior Troop Nos. 60438, 60498, 94016, Cadette Troop Nos. 60526, 60535, 60606, 60613, 61109, 61180 and Senior Troop Nos. 61386 and 60469, totaling 310 Girl Scouts.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Hasbrouck Heights, County of Bergen, State of New Jersey, hereby congratulates the Girl Scouts of America on its 100<sup>th</sup> Anniversary, and especially extends its gratitude to the many Girl Scouts and their Leaders of Hasbrouck Heights, past and present, who have exemplified the Girl Scout Promise of serving God, Country, helping people at all times and living by the Girl Scout Law.
