## MISCELLANEOUS FROM PUBLIC:

Mayor Heck requested a motion to open the meeting to the public which was made by Councilman DiPisa, seconded by Councilman Gonzalez, and unanimously carried.

John Goehrig, 262 Lawrence Avenue, said he had his sidewalk fixed the other day whereby the contractor was not permitted to cut the roots, the town must do so, who couldn't get them all. The contractor did remove the rest of the roots but at a cost of \$200. He questioned why other towns reimbursed residents for sidewalk repair. Mr. Kronyak noted ordinances in place for many years name the homeowner responsible for repair of sidewalks. Possibly other towns had a Shade Tree Commission which creates a different liability to municipalities. Mr. Spindler, who had met with Mr. Goehrig on this issue, said the town's machine can only get as close to the tree as he wanted because of the blade guards. He never encountered where sidewalk repair was paid for by the Borough. He presented a picture that showed a swarm of bees on his fence since Sunday and had called various people who couldn't help him. He was advised to call a beekeeper. Mr. Kronyak would check with the County.

There being no one else wishing to speak, Mayor Heck asked for a motion to close the public portion which was made by Councilman Gonzalez, seconded by Councilman DiPisa, and unanimously carried.

### WORK SESSION:

Mayor Heck asked if no one objected, the meeting would go right into Work Session. There were no objections.

# ADJOURN:

There being no further business to be conducted by the Mayor and Council, the meeting was adjourned at 9:14 p.m. on a motion by Councilman Lipari, seconded by Councilman Gonzalez, and unanimously carried.
