UPDATE ON CURRENT 2014 BEST PRACTICES INVENTORY - *CFO/Admin. Michael Kronyak*

Mr. Kronyak noted that since 2011 he has been preparing this report which consists of 50 questions to hit highlights of what every municipality may have to deal with. Most questions are yes or no, with explanations in the comments section. You must receive a grade of 80% of positive answers, you would not have a reduction in the last State Aid payment. Our final State Aid payment is about \$51,000. The penalty would be \$2500-\$2600, but having to explain would be the bigger issue. This is due by October 17, 2014. There were 35 yes answers, 4 no answers, not applicable 9, and perspective 2. Our score is 92%, it will be sent to Trenton. Councilman Semenecz asked if this served any purpose. Mr. Kronyak said it gives towns the opportunity to qualify their answers, but could lose money and could be a distressed city. They ask about shared services. He thought the intent is to see if we are complying with all regulations that change annually.
