# **Lowering Energy Prices**

"I have even more good news for our customers. In a filing made on May 29 with the New Jersey Board of Public Utilities, PSE&G has proposed an additional price reduction in natural gas bills that, if approved, would reduce residential gas bills by 9 percent this winter, saving customers about \$100 a year. The proposal would reduce our basic gas supply rate to 45 cents per therm, the lowest rate in 14 years and the lowest in the state."

Mayor Heck asked if Borough Attorney Chandless and Councilman Lipari would be attending the Wood-Ridge Planning Board Meeting on July 16. They advised her that at least one of them would be attending.

Mayor Heck then asked for a motion to accept the Communications, which was made by Councilman Semenecz, seconded by Councilwoman Buckman, and unanimously carried.
