September 9, 2014

A Regular Meeting of the Mayor and Council of the Borough of Hasbrouck Heights was held on September 9, 2014 at 8: 07 p.m. at Borough Hall, 320 Boulevard, Hasbrouck Heights, NJ.

Mayor Heck declared the meeting in Session and Borough Clerk Rose Marie Sees stated that the meeting complied with the Sunshine Law, adequate notice of this meeting having been made to all members of the Council by personal service on January 2, 2014 and transmitted to The Observer, The Record and The Herald News on January 2, 2014.

PROCLAMATION: Councilman DiPisa read the following Proclamation in honor of the 95th Anniversary of American Legion Captain James B. Scarr Post 106

WHEREAS, in November 1918, after the termination of hostilities in World War I, certain American officers who had been participants in the conflict began to think about the creation of an ex-soldiers organization for the nearly two million men who had shipped out for European duty; and

WHEREAS, on March 15, 1919, a representative group of officers and men who were still overseas held a caucus in Paris, France, and founded the "American Legion", and on September 16, 1919, the U.S. Congress charted the American Legion as a mutual aid veterans organization founded to benefit those veterans who served during a wartime period as defined by the U.S. Congress; and

WHEREAS, on September 3, 1919 a group of veterans from Hasbrouck Heights, New Jersey saw a need to form a local organization for veterans and met with Mr. Mulliken, Bergen County Field Secretary, and founded the American Legion Captain James B. Scarr Post 106 in honor of a local resident who had died in service, and elected as their first officers F. J. Scarr, Commander; M. M. Sheedy, Vice Commander, E. C. Ellis, Finance Officer and A. E. Brown Adjutant; and

WHEREAS, ninety-five years have passed since that date and today the American Legion Captain James B. Scarr Post 106 is as active as ever with Michael J. Cahill serving as Commander, Patrick McCarthy, First Vice Commander, Joseph T. Cavalli, Second Vice Commander, Frank Zabrowsky, Adjutant, Gilbert A. Hunt, Finance Officer, Stephan Herinya, Chaplain, Joseph F. Romano, Sergeant at Arms, Melvin Thompson, Service Officer, Robert J. Burns, Membership Chairman and Peter J. Gallo, Boys State Chairman; and

WHEREAS, over the years American Legion Captain James B. Scarr Post 106 has been deeply involved with various Veterans charities, organized and maintained an effective Civilian Defense League when needed, donated Thanksgiving and Christmas baskets to needy veterans families, sponsored Memorial Day and Veterans Day

ceremonies, supported Veterans homes; continuously sponsored Boys State and Eagle Scouts; held an Essay Contest on Patriotism, financially supported the Free Public Library and since 2010 has awarded a scholarship to a deserving local high school graduate.

NOW, THEREFORE, BE IT RESOLVED that we, the Mayor and Council of the Borough of Hasbrouck Heights, County of Bergen, State of New Jersey, hereby commend and recognize the American Legion, particularly the Captain James P. Scarr Post 106 for its ninety five years of dedicated service to the Country and the Community, and hereby applaud their work with our Veterans and their service to the United States of America.

PROCLAMATION: Mayor Rose Heck read the following Proclamation in honor of the 70th Anniversary of the Contemporary Club of Hasbrouck Heights:

WHEREAS, the Contemporary Club of Hasbrouck Heights, originally called the Evening Department of the Woman's Club of Hasbrouck Heights, was incorporated as a separate organization in the New Jersey Federation of Woman's Clubs in September of 1944; and

WHEREAS, Charter Members included Evelyn Basralian, Louise Eckert, Elsie (Carell) Freud, Virginia DiMaria and Bernadine Delvin; and

WHEREAS, the Contemporary Club of Hasbrouck Heights started with 30 members and grew to as many as 100 members in the 1980s and currently meets the 4th Tuesday of the month in Holy Trinity Lutheran Church; and

WHEREAS, there have been 34 different presidents in 70 years including Mrs. James R. Freeman, Mrs. Bernadine Delvin, Mrs. Everett J. Freud, Mrs. Horace Besecker, Jr., Mrs. Helen Staton Andre, Mrs. Warren C. Hyer, Mrs. Anthony Mancari, Mrs. Edward Newkirk, Jr., Mrs. Margaret Gascoyne, Mrs. Ralph R. Ilaria, Mrs. Emmett Weston, Mrs. Henry Kalish, Miss Helen Muller, Mrs. Andrew Cevasco, Mrs. Stewart Kidney, Mrs. Stanley Melenick, Mrs. Sherman Babcock, Mrs. Emil Osol, Mrs. Raymond L. Heck, Mrs. John D'Avria, Mrs. John W. Menne, Mrs. Peter Bruinooge, Mrs. Joseph Iannucci, Mrs. Joseph Corso, Mrs. Fred Jaeger, Mrs. William Kremer, Mrs. Herbert D. Heeren, Ms. Patricia Link, Mrs. Anthony B. Bernice, Mrs. Helen O'Shea, with some members serving on the State level of the New Jersey Federation; and

WHEREAS, the club has volunteered and helped raise funds for many projects including Feed the Homeless, Autism, Domestic Violence, Shelter our Sisters, various cancer projects and children's hospitals; and

WHEREAS, the club has sponsored a High School Scholarship annually, and sponsored "Candidates Night" for over 50 years when candidates for the Board of Education were given the opportunity to present their views to the electorate.

NOW, THEREFORE, BE IT RESOLVED that we, the Mayor and Council of the Borough of Hasbrouck Heights, County of Bergen, State of New Jersey, do hereby congratulate the Contemporary Club of Hasbrouck Heights on its 70th Anniversary, with sincere gratitude for being such a vital part of the community and extend our best wishes for continued success in the future.
